PA Noted the following:

- Aware of extra traffic because of road works
- Some works carried out in the parish
- No detailed plans for Cyberpark as yet but will forward when received

MH asked – Traffic has increased because of work to bridge but speed is not self-enforcing, and Craig Freeman has stated we need some evidence for Police for temp speed restriction. Have you any weight to bear in getting signs, traffic use is almost back to pre-Covid levels, and he cited his own example of the impact of speeding traffic while out walking

PA agreed to contact Chris Riley to try to do something and also take it up with cabinet member as works are set to continue for over 12 months

DL added it is a powerful statement that parishioners are having to restrict their lifestyle when out and about especially as more people are now walking

MH asked - Do we need permission from Highways to site dog bins, PA confirmed we need to ask Craig Freeman CF for permission, and asked to be copied in to email

MW asked - Were there any details on Traffic survey camera he had noticed on road into Barrow from Staverton PA: considered it could be in connection with the cyberpark or the reuse at MOD – will discuss with CF

MW reported TBC are ticking over and slowly going back to work

751/ Proposed alterations to M5 Junction 10

751.1 The proposed new Link road in the Cyber Central - WEST CHELTENHAM STRATEGIC MASTERPLAN 1. The Hayden Hill Community on Old Gloucester Road

J10 opening in 2024, there will be a public consultation

752/ Dog fouling on grass verges and the siting of Waste Bins and Dog Bins

GR: Reported there is a lot of dog fouling in the parish and residents have suggested dog bins, one could be sited on corner in Barrow by T- junction as nowhere else is suitable

This was agreed as a trial, Clerk to ask TBC for a bin and installer, to be delivered to RH house and to ask GCC for permission to put on verge. MW also agreed to supply notices

753/ Signage for Boddington Lane

MH reported there is no update on speed indicator devices SID, but added we are unlikely to fulfill the necessary requirements

Closure of bridge at Staverton till August 2021 - noticed speeding cars on Boddington Lane, number of vehicles has increased significantly, raised with Craig Freeman but he cannot put in a temporary speed limit. As it has to go through the police, and we do not meet the criteria with traffic and accidents so no real progress, this would have been helpful to know in the first place

There is a traffic survey camera on the speed sign leaving Barrow, could be from MOD at Boddington but has raised with CF

Gates on hold but could still do this separately from the SID Future agenda Item

754/ Website Accessibility Compatibility

The Clerk has highlighted that all websites must be website accessibility by 23rd September. GC has investigated this, and noted it is very time consuming – and we need to do a lot to website to upgrade it. She expressed concern on using Captcha and will need to go through every pdf plus technology checks. We also need to produce an accessibility statement, there is however a disproportionate statement clause we could use

Members thanked GC for being continued her work on this
